

- ⇒ Endnotes/footnotes should appear in the order that they occur in the essay.
- ⇒ Endnotes/footnotes should be numbers and the first line should be indented half an inch.
- ⇒ Bibliography pages should be arranged alphabetically according to the author's last name or the title of the work.
- ⇒ Bibliography pages have no numbers and use a hanging indent of half an inch.
- ⇒ Entries for both the Endnotes and Bibliography pages are single spaced with double spaces between each entry (unless the instructor specifies otherwise).
- ⇒ Author's names are NOT inverted for footnotes/endnotes and ARE inverted (last name first) for Bibliography pages.

# **Chicago Format**

Chicago format is known for the use of endnotes or footnotes as opposed to parenthetical citations. It also usually includes a Bibliography at the end of the paper. Your instructor will indicate what is necessary for your paper. Two types of citations will be listed in this pamphlet: the footnote/endnote (N) and the Bibliography (B).
